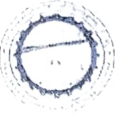
## GENERAL CONDITIONS

1. Minimum qualifications and/or experience mentioned above are subject to rules/regulations/ norms/ directives including amendments in the present regulations as stipulated by the AICTE/ UGC / PCI/ State Govt. or any other Competent Authority applicable to such recruitments.
2. Applicants must fulfill the minimum qualifications and/or experience prescribed for the posts. Period spent by the candidates to acquire Ph. D. degree shall not be considered as research experience.
3. It shall be the responsibility of the candidates to assess their eligibility for the post for which they are applying in accordance with the prescribed qualifications and/or experience and submit the application duly filled-in, along with the desired information and documents as per the advertisement.
