

Memorandum of Understanding

BETWEEN

The signatories Secretary, the institution of Electrical & Computer Engineers (India) herein referred to as IECE (I) and the HOD, Madan Mohan Malviya Engineering College herein referred to as Institution have agreed herewith to execute this MoU consisting of the following clauses with signatures of the said designated authorities will come into force with immediate effect.

Role And Responsibilities of IECE (I):

IECE(I) will register candidates through its Institutional Member(Students' Chapter) for their being non-corporate members IECE(I) i.e. Associate Member IECE(I) and Technician Member IECE(I) on the dates notified by it.

- 1) The IECE(I) will conduct the following examinations twice a year i.e. in the month of June and December.
 - A) DIPLOMA EXAMINATION
 - i) Electrical Engineering
 - ii) Computer Engineering
 - B) DEGREE EXAMINATION
 - i) Electrical Engineering
 - ii) Computer Engineering
- 2) On successful completion of the theory papers of Part II examination for Technician Membership Examination or all subjects of the section B examination for Associate Membership Examination, the candidates will be required to undergo practical training and submission of project report before their certification by IECE(I).
- 3) IECE(I) will get the candidates (for practical training and project report submission) registered with AICTE approved polytechnics and engineering colleges through the Institutional Member (students' chapter) and get the practical test conducted by the concerned polytechnics and engineering colleges where the candidate undergoes practical training.
- 4) Institutional Member (students' chapter) of IECE(I) will pay for the charges towards conduct of practicals & submission of Project Report as are prescribed by the Institution for the above purpose to the concerned Polytechnic/Engineering colleges on completion of the practicals /submission of project report and the Award list to IECE(I).

Role and Responsibilities of the Institution:

- 1) The Institution will register candidates as referred to it by Institution Member Students' Chapter of IECE(I) for practical training and practical tests and for forwarding the project reports through the Principal or the Head of the Department of the Electrical Engineering/Computer Engineering.
- 2) The list of Practical will be as approved by IECE(I).
- 3) The practical tests and project report will be assessed by the institution concerned and the awards forwarded to IECE(I) in a confidential cover by the stipulated date. The assessment will be done in Grades A, B+,B only.
- 4) The institution will ensure that the candidate submitting the project report has spent one semester i.e. approximately six months on its completion after passing Part II/Section B examination.
- 5) The candidate registered with the institution shall remain under the disciplinary control of the Head of the institution and any violation therein shall be reported to the Chairman IECE(I) with whom authority for the discipline and disciplinary action vests.
- 6) The institution will be responsible for regular and smooth functioning of the arrangement of practical training and test and also for forwarding of project report of the candidate.
- 7) This MoU will remain valid in all normal circumstances for a period of five years but may be renewed after every five years (with escalation in rates for practical charges as may be mutually decided). The MoU may not be extended beyond five years if both the parties confirm the same in writing at least six months prior to its expiry.
