Participation Eligibility (Who can apply?)

- 1. Eligibility for Admission to M.Tech Programme:** Candidates who have passed Bachelor's Degree in Engineering /Technology or equivalent, or as prescribed by the AICTE with **at least 50% marks (45% marks in case of candidates belonging to SC/ST)** are eligible for admission to M.Tech. programme.
- 2. Eligibility for Admission in M.Sc. Physics:** The candidate should have passed the recognized bachelor's degree in science stream of minimum three years duration from any University of India as recognized by UGC. The candidates must have passed qualifying examination with Physics as a subject for all the three years and with mathematics as another subject for at least two years and obtained minimum 50% marks (45% in case of candidates belonging to SC/ST category) in the qualifying examination.
- 3. Eligibility for Admission in M.Sc. Mathematics:** The candidate should have passed the recognized Bachelor's degree in science stream of minimum three years duration from any University of India as recognized by UGC. The candidates must have passed qualifying examination with Mathematics as a subject for all the three years and obtained minimum 50% marks (45% in case of candidates belonging to SC/ST category) in the qualifying examination.
- 4. Eligibility for Admission in M.Sc. Chemistry:** The candidate should have passed the recognized Bachelor's degree in science stream of minimum three years duration from any University of India as recognized by UGC. The candidates must have passed qualifying examination with Chemistry as a subject for all the three years and obtained minimum 50% marks (45% in case of candidates belonging to SC/ST category) in the qualifying examination.
- 5. All the eligible candidates with valid GATE/CUET(PG)-2024 score who were earlier registered for admission to M.Tech and M.Sc and successfully paid the registration fees of Rs. 2,500/- for counselling conducted by M.M.M. University of Technology, Gorakhpur, but failed to get a seat or withdrew his/her candidature from online counselling at any stage. (Such candidates need to give consent through google form sent on their registered e-mail for spot counselling. These candidates are not required to pay Rs. 2,500/- as registration fee again.)**

6. All the eligible candidates **with valid CUET(PG)-2024/GATE** scores who have not participated/registered in prior counselling conducted by MMMUT, Gorakhpur. *(Such candidates should register themselves using the link given in the above table and need to pay Rs. 2, 500/- as registration fee using registration portal between September 11, 2024 (11:00 AM) to September 14, 2024 (11:00 AM)).*
7. All the eligible candidates **without valid GATE/ CUET (PG) 2024** score who have not participated in prior counselling conducted by MMMUT, Gorakhpur. *(Such candidates should register themselves using the link given in the above table and need to pay Rs. 2,500/- as registration fee using registration portal between September 11, 2024 (11:00 AM) to September 14, 2024 (11:00 AM)).*
8. Candidates with valid GATE/CUET (PG) 2024 score are not required to appear in any written examination. They can directly participate in counselling process on **14 September 2024** for physical document verification.
9. Candidates without a valid GATE/CUET (PG) 2024 score will appear in one hour examination of multiple-choice type.
10. GATE-qualified candidates will be preferred over CUET(PG) for the allotment of seats against the remaining vacant seats of M. Tech. programs.

Seat Allotment

Information regarding vacant seats is available at the end of this notice. The vacant seats shall be allotted as per the combined general rank (GN) of the candidates present at MMMUT for spot counselling. No category/sub-category benefit shall be given in spot round for seat allotment.

Process for Participation

Candidates fulfilling the above eligibility criteria should successfully registered on the counselling portal for spot counselling and report personally to the Admission Cell, Madan Mohan Malaviya University of Technology, Gorakhpur, on **September 14, 2024, at 10:00 AM.**

Documents Required

The candidates must bring all the original documents with one set of self-attested photocopies for physical document verifications.

**** M.Tech candidates can also be admitted by depositing semester fees only i.e. Rs. 61,250/-.** Such candidates will deposit the remaining fees of Rs. 61,250 at the time of second semester registration. **For M.Sc candidates payment of Rs. 25,000 is mandatory.**

Important Note:

1. After seat allotment (if offered), the candidate has to immediately deposit the Annual University Fee through a demand draft in favor of “**Madan Mohan Malaviya University of Technology, Gorakhpur**” payable at **Gorakhpur**. Failing which, the seat allotment shall be cancelled, and the seat will be offered to the next available candidate as per his/her rank. All important information regarding admission to M.Tech. and M.Sc. programs is available on the link http://www.mmmut.ac.in/pg_admission. **M. Tech eligibility criteria has been changed. Candidates should refer to Point 1 of eligibility criteria as given in this notice instead of eligibility criteria given in brochure.**
2. **The above fees does not include hostel and Mess fees**. The hostel fees is to be submitted online only after allocation of hostel as per university rules. The link for hostel and mess fees deposition will be provided by the office of Dean of Student Affairs.
