Student Exchange Memorandum of Understanding

Between

Madan Mohan Malaviya University of Technology (MMMUT), Gorakhpur, India

And

the Faculty of Engineering, University of the Ryukyus, Japan

Madan Mohan Malaviya University of Technology (MMMUT), Gorakhpur, India and the Faculty of Engineering, University of the Ryukyus, Japan shall exchange undergraduate and post graduate students for purpose of education and research under this memorandum based on the International Exchange Agreement between Madan Mohan Malaviya University of Technology, Gorakhpur and the Faculty of Engineering, University of the Ryukyus signed on October 16, 2017.

1. Number of Exchange Students

Each university may send and accept under this memorandum not more than 5 students each academic year.

2. Duration of Stay

Duration of stay for exchange students at the host university shall be in principle up to one academic year.

3. Selection of Exchange Students and Acceptance Procedures

The home university shall initially select students to participate in the exchange program under the terms of this memorandum, but the host university shall make final admission decisions in each case.

4. Study Program

The host university shall determine a study program suitable for each student with the students' academic background and preference taken in to consideration.

5. Status of Exchange Students

Each university shall accept exchange students as non-degree-seeking students at the host university.

6. Academic Record and Accreditation

The host university shall evaluate the academic performance of each students pursuant to its rules and shall send to the home university the academic record or transcript of each exchange students. The home university may give credit to each student in accordance with its requirements.

7. Waiver of Tuition and Fees

Each host university shall provide waiver of entrance examination fees, admission fees and tuition for the exchange students.

8. Financial Responsibility

Exchange students shall take out comprehensive health insurance that is valid at the host university and shall be responsible for such expenses as travel, accommodations and health care.



9. Accommodations

The host university shall do its best to secure appropriate accommodations for exchange students.

- 10. This memorandum shall not ensure the availability of scholarships for exchange students, but each university shall endeavor to provide useful information on scholarship programs that will financially assist the students.
- 11. This memorandum is subject to revision or termination by mutual consent, although such action shall only by taken after mutual consultation in order to avoid any possible inconvenience to the other party. Termination by any Party must be communicated in writing to the other with at least three month's advanced notice.
- 12. This memorandum shall become effective when the representative of both institutions have fixed their signatures hereunder and shall be effective for FIVE years. It may be renewed with the consent of both institutions through the exchange of letters confirming the renewal within six months prior to the end of the term, and will be effective for another five years. In the event that this student exchange memorandum between the two institutions is superseded by a university level memorandum between the two universities, this memorandum shall be rendered null and void.

and for the Madan Mohan Malaviya University of Technology (MMMUT), Gorakhpur –Prof. S. N. Singh, Vice – Chancellor, Madan Mohan Malaviya University of Technology, Gorakhpur (U. P.) – India.

The reference persons of the Parties or their designated representatives shall correspond or meet whenever necessary to discuss the implementation of this MoU.

Madan Mohan Malaviya University of Technology, Gorakhpur, India and the Faculty of Engineering, University of the Ryukyus, Japan consent to enter into a formal agreement, based on a foundation of mutual trust established by previous exchange programs, to promote further exchange of students, faculty, and staff in order to advance scientific research, education, and cultural understanding, and to contribute to the mutual benefit and development of the two institutions.

- 1. The two institutions shall promote the following exchange activities based on their respective academic and educational needs:
 - (1) Exchange of students
 - (2) Exchange of faculty and staff members
 - (3) Exchange of academic materials, publications, and information
 - (4) Joint hosting of seminars, conferences, and symposia
 - (5) Joint research
 - (6) Other academic exchanges
- 2. The implementation of each exchange based on this agreement shall be separately negotiated and determined by both institutions. Exchange activities shall be carried out within the scope of each institution's financial, material, and institutional limitations. With this understanding and the mutual agreement of both institutions, memoranda based on this agreement may be signed.
- 3. Nothing shall diminish the full autonomy of either institution, nor will either party impose any constraints upon the other in carrying out the agreement.
- 4. This agreement is subject to revision by mutual consent. It is also understood that either institution may terminate the agreement at any time, although such action shall only be



taken after mutual consideration in order to avoid any possible inconvenience to either party.

5. This agreement shall be effective when the representatives of both institutions have signed the agreement and is valid for a term of five years. It may be renewed with the consent of both institutions through the exchange of letters confirming the renewal within six months prior to the end of the term, and will be effective for another five years. In the event that this international exchange agreement between the two institutions is superseded by a university level exchange agreement between the two universities, this agreement shall be rendered null and void.
