**Madan Mohan Malaviya University of Technology** (herein after referred to as "**MMMUT**") which expressions shall, unless repugnant to the context, mean and include its successors and permitted assigns) has authorised **Dean Planning & Alumni Relations, MMMUT** enter this **MOU** as the **SECOND PARTY**.

"**CSSRL**" and "**MMMUT**" are hereinafter, wherever the context so admits, collectively referred to as the "**Parties**" and individually as a "**Party**".

AND WHEREAS the purpose of MoU is to establish an understanding of mutual cooperation between **CSSRL** and **MMMUT**, providing a common platform for deriving mutual advantages in their pursuit of higher learning in general and benefiting their respective students and faculties, by way of exposure to each other's programs, in particular.

#### Article I: Scope

- a) The initially proposed activities within the scope of the current MoU are:
- Cyber Security Lab setup for training purpose
  - Training for identified faculties and deputation of Dedicated Premium Evangelist from **CSSRL** who can train students on ongoing basis
  - Support to these faculties on need basis and periodic training sessions to stay up to date on technology






- Ongoing support for laboratory to keep it updated/upgraded and to help troubleshooting issues if any
  - Conducting workshops/seminars/boot camps for cyber security awareness
  - On Campus Training and Incubation services for MMMUT students on Industrially Tailored Security Programs and Modules on pre-negotiated fees. These students can utilise the lab setup above if needed.
- b) Special offers to MMMUT students for internship opportunity at CSSRL.
- c) Defining new areas of collaboration and academic integration that have not been foreseen but can be beneficial to the Parties.
- d) For carry out joint research on the topics of mutual interest.

### Article II: Duration, Termination and Amendment

- a) The MoU will be effective from the date of signing by both parties for a period of up to five (5) years and may be subject to extension by mutual consent of the Parties, expressed in writing.
- b) Either party may terminate this MoU by giving six (6) months' notice in writing to the other Party.
- c) The provisions of the MoU may be amended at any time with the mutual consent of the Parties in writing.
- d) The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination and expiration, unless otherwise agreed upon between the Parties.
- e) No action undertaken shall diminish the full autonomy of either institution, nor will either party impose any constraints upon the other in carrying out the agreement.

### Article III: Special Provisions

- a) Each Party will consult with, and take approval of, the other Party to use the latter's name, the names of the latter's officials / faculty members, and logo for the activities under this MoU, and dissemination of results, on a case by case basis.
- b) Detailed modalities of individual forms of collaboration, activities associated with them and financial aspects of each shall be mutually agreed upon on a case by case basis, and specified, with all necessary details, in separate Agreements.
- c) This MoU will not be legally & financially binding to any of the Parties. The two Parties will consult with each other and attempt to resolve disputes or misunderstanding that arise in the administration of this MoU or any subsequent associated Agreement informally.






