Participation Eligibility (Who can apply?)

- 1. Candidates registered by paying Rs. 2500/- for online counselling conducted by Madan Mohan Malaviya University of Technology, Gorakhpur but failed to get a seat. Seat Allotment

The vacant seats shall be allotted as per score of the candidates present at MMMUT for spot counselling. No category/sub-category benefit shall be given in spot round seat allotment.

Process for Participation:

All candidates successfully registered on counselling portal should report personally at Multi-Purpose Hall, Madan Mohan Malaviya University of Technology, Gorakhpur on August 13, 2025 up to 10 am. The candidates are required to report with all original documents with one set of self-attested photocopies of the same at MMMUT, Gorakhpur.
